

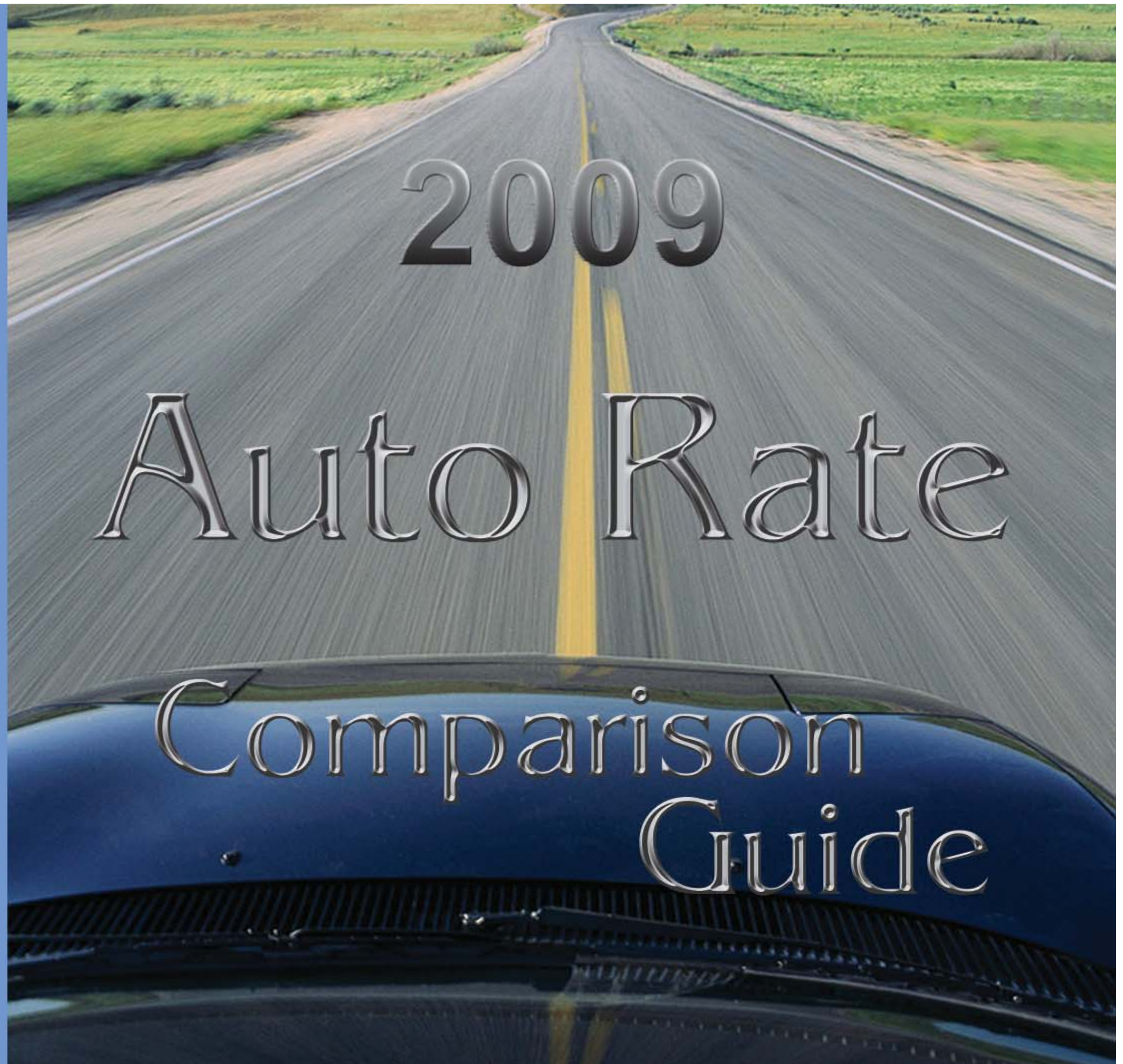

Welcome to the *2009 Louisiana Automobile Rate Comparison Guide*.

The companies listed here are some of the top carriers of automobile insurance in Louisiana based on premium volume. Included is a display of premium quotes for various rating situations (e.g., location, driver age and vehicle age). For your convenience, we have added links to the company Web sites where available. You can access these links by clicking on the company name in each example. **Keep in mind these examples may not precisely reflect your individual circumstances. Also, you may find that a company not included in this guide can best provide the coverage and service you need.**

When shopping for insurance, look for a company that is financially sound, has a history of good service and charges a fair rate. Remember, no matter how low the premium might be, an inexpensive policy does you no good if the insurance company cannot cover your claim after your car has been involved in an accident.

Please contact us to find out if any complaints have been filed against the company or producer (agent) you are considering. Also, be sure to ask for the company's A.M. Best rating, which shows the financial strength of the company and its ability to meet obligations to policyholders. I hope this guide assists you in your search for the right auto insurance.

To provide you with a better idea of cost, we offer separate rate comparison guides for automobile and homeowners insurance. Tips:

1. Use this rate guide as a starting point.
2. Search through the yellow pages for help in contacting producers (agents) or companies.
3. When you start calling for price quotes, be ready to answer questions concerning your driver's license, traffic records, estimated miles driven to and from work, and total miles driven each year.
4. Inquire about discounts. Some companies grant premium reductions based on your good driving record, limited vehicle usage, multiple vehicles, safety and theft devices, and other factors.
5. Ask questions about how your policy works. Since you will be paying for your policy, you have a right to know all the policy details.
6. Compare policies and choose the one best suited to your situation.
7. If your car is older and paid for, consider dropping collision and comprehensive coverage. Compare the cost of your annual premium with the car's "Blue Book" value, minus your deductible.

Terms:

Liability insurance pays for damages or injury to another person outside your household for which you may be legally responsible.

Comprehensive insurance covers a wide range of potential damages to your vehicle, including fire, theft, vandalism, and glass breakage. Deductibles on comprehensive insurance range from zero to \$250. The higher the deductible, the lower the premium. For example, with a \$250 deductible, your premium cost would be less, but you pay the first \$250 anytime you have a comprehensive claim.

Collision insurance covers you for exactly that: collisions that damage your vehicle. Collision deductibles generally range from \$100 to \$500 or more. Again, the higher the deductible, the lower the premium.

Credit scoring is a numerical value which assesses an individual's credit worthiness (i.e. reliability for paying bills). Credit scoring is used by many insurance companies as a rating factor for auto insurance.

Deductible is the amount you pay out of your own pocket when you have a claim.

Exclusions are certain situations under which your policy will not cover you or your vehicle.
