**STIPULATION OF MEDIMPACT HEALTHCARE SYSTEMS, INC. AND AmCARE
HEALTH PLANS OF LOUISIANA, INC. IN LIQUIDATION**

James J. Donelon, Commissioner of Insurance for the State of Louisiana as Liquidator for AmCare Health Plans of Louisiana, Inc. In Liquidation, through the Court-appointed Deputy Receiver, Marlon Harrison (“AmCare-LA”), and MedImpact Healthcare Systems, Inc.

(“MedImpact”) hereby reduce to writing the stipulation entered into and read in open court on March 12, 2012 as to the proof of claim submitted by MedImpact in the AmCare-LA liquidation and the opposition of AmCare-LA to the MedImpact proof of claim:

- 1) On February 15, 2012, MedImpact propounded a first set of interrogatories and requests for production of documents to AmCare-LA, to which AmCare-LA responded on February 24, 2012.
- 2) On February 28, 2012, MedImpact propounded a second set of requests for production of documents to AmCare-LA, to which AmCare-LA responded on March 13, 2012.
- 3) On February 28, 2012, AmCare-LA propounded interrogatories and requests for production of documents to MedImpact, but at present MedImpact has not responded.
- 4) The parties consider that MedImpact may seek to take the deposition of Cara (formerly Girouard) Bostick and Advanced Pharmacy Concepts as to the MedImpact proof of claim and related issues and that AmCare-LA may seek to take the 1442 corporate deposition of MedImpact, said depositions to be taken within the next forty-five (45) days, on or before April 27, 2012.
- 5) The parties consider that a rule to show cause and/or other pleading(s) may be filed as to legal issues identified and that such motion will be filed within the next forty-five (45) days, on or before April 27, 2012, with a hearing to be set within the next sixty (60) days, on or before May 15, 2012.

- 6) The parties consider that the final hearing as to the proof of claim submitted to AmCare-LA by MedImpact will be set by May 15, 2012 at the latest.




